

Shizuoka City's Grant based on Suspension of Business Request for the Purpose of Preventing the Spread of COVID-19

1 Businesses eligible to receive the Grant and criteria for eligibility

(1) Businesses eligible to receive the Grant

SMEs (small & medium sized enterprises) and private businesses who cooperated with the request for suspension of business from the city and establishments who closed in response to the city's request.

(2) Application Criteria

Small & medium sized enterprises and private businesses who cooperated with the request for closure for the entire period from 27 April (Mon.) ~ 6 May (Wed.) 2020.

2 Amount of Grant

1 ¥500,000 per business ※businesses that run two establishments or more will be granted ¥1,000,000

※The grant from Shizuoka Prefecture can also be utilized.

3 Procedure for Application

(1) Application period

- Applications will be accepted between 7 May (Thurs.) ~ 30 June (Tues.) 2020.
- The grant is scheduled to be deposited after the middle of May (scheduled period is subject to change).

(2) How to apply

- By online application through the website
- By post (by registered mail or LETTERPACK which can be tracked.)

(3) Documents necessary for application

※Businesses & establishments etc. that operate within the city are eligible to apply for the Shizuoka Prefecture Special Grant can also be made through the Shizuoka City Application Office.

※Conditions for application is the suspension of business operation to all requests by businesses subject to business closure within Shizuoka City.

※If you run more than one business or establishment, please provide information for all the businesses on the application form.

- A) Application for Special Grant/Confirmation of Situation Form
- B) Written Oath

- C) Documents showing proof of business operation (copy)
- D) Business license, etc. documents to show approval to do business for the specific industry
- E) Document for self identification (copy)
- F) Documents to show that the business has been suspended for the specified period of time
- G) Document showing the area of space of establishment (if area conditions apply for the specified business)
- H) Copy of the passbook page indicating account details for deposit of grant payment
- I) Checklist
