Please inquire at the numbers below.</p> <p><b>Application Period:</b> Please note that the deadline for reductions and exemptions is 7 days before the relevant payment deadline (or 7 days before each eligible pension payout date in the case of special collections (特別徴収, <i>tokubetsu choshu</i>)).</p> <p>*The deadline for term 1 health insurance fee reduction/exemption applications (regular collections) is Mon 24 June. If you have any queries, please inquire before the deadline.</p>
